All the Leases except Catherine Dowling, Widow of J Dowling ARP 22-1-0, Jas Gorman & Tim & John Gorman in the possession of R Eustace. I have not got Abel Wall's Lease, but was assigned by Wall to Bunbury 25th May 1778. It appears that Abel Walsh sold his Interest in it to Geo. Bunbury for £ 800. The Memorial of the fee was entered in the Registrar Office in Dublin the 27th May 1778/ in Book 320 page 302 & Number 216067 & the Execution of ? Deed & Memorial as duly noted __

all the Leases were executed by Geo. Bunbury, but the big Famine and Gorman's by Benj. Bunbury & those in R Eustace's Possession
