

By the Tenor of these presents We William & Sophia
 Do make known unto all Men, That Whereas our
 beloved the Right Honble and Right Worshipful John
 Keadeliffe Esq^r of Law^r our Commissary in the said
 Court^r in a certain business of proving in special form
 of Law the Last Will and Testament or testamentary
 disposition in the Writing of Daniel Mills King late
 of Kingstown in the County Wicklow Esq^r of the
 a Widower deceased^r having & before^r and of showing
 Cause^r if any^r why the burden of the execution thereof
 should not be granted and committed unto Daniel Mills,
 the Natural and lawful son, one of the Next of Kin
 and one of the Executors named in said Will, which
 lately depended in judgment before him, between the
 said Daniel Mills, the party promoting the said
 business of the one part, and the Rev^d James Lyons
 Clerk, one other of the Executors named in said
 Will, and Thomas Mills King, Joseph Mills and John
 Mills the Natural and lawful Children and only other
 Next of Kin of said deceased, the parties against whom
 the said business was promoted of the other part the
 Mills the other Executor having renounced. Rightly
 and duly providing^r Read, Signed and promulged a
 certain definitive Sentence in Writing, Whereby he pro-
 nounced, Decreed and Declared that, the said Daniel
 Mills King, the deceased, having a mind and intention
 to make his Last Will and Testament in Writing and
 being at such time of sound and disposing Mind,
 Memory and Understanding, though extremely ill, and
 of the illness of which he afterwards died^r did on
 or about the 11th day of September 1818, ^{give} Verbal

instructions to a faithworthy person to prepare his will, and took down truly and exactly according to said deceased's direction and afterwards by deceased being read same truly and distinctly to said deceased, as so taken down and as now appears. Whereupon said deceased expressed his full and entire approbation thereof, and his wish and intention to execute a formal Will to be prepared therefrom conformable thereto, and at same time gave directions to have such formal Will prepared, or engrossed therefrom, for his execution, adding that he would execute same on going next to the town of Wicklow; which he then expected he would be able to leave his House for in a few days, he said deceased or said person not then apprehending his immediate dissolution, shortly after which directions he said deceased died suddenly without having executed said instructions or such formal Will. And did pronounce Decree and Declare that said deceased, did give, will, bequeath devise, dispose and do in all things as in said Will is contained, beginning "£ 500 lount tott" and ending "Thomas not to take any part" is contained and did pronounce, Decree and Declare for the force and Validity of said testamentary disposition in Writing of said deceased, and did Approve of and receive the same "Justice so requiring" We therefore grant the burden of the execution of said Will or testamentary disposition in Writing, to the aforesaid Daniel Mills, one of the executors, he being first sworn personally, the right of the Revd Ed Lynor the other
